Cllr Wittam announced the passing of former Councillor, Bill Bishop. He was a very prominent and well respected figure in the town and Town Council, who will be greatly missed. As a mark of respective a minute's silence took place.

1 **APOLOGIES** for absence and approval of reasons tendered. Cllr P Etherington, Cllr N Siebert – apologies accepted.

DECLARATION OF INTEREST and additions to Members Register of Interest. None.

3 TO RECEIVE A REPORT FROM SQN LDR GEARY - RAF LAKENHEATH

Sqn Ldr Geary was accompanied by Victoria Quamina the Community Relations Adviser for the 48th FW. She left business cards with her contact details.

Sqn Ldr Geary reported that in addition to the continuing operational commitments and the routine training sorties required to retain currency and competency on the aircraft, 48FW aircraft participated in Exercise Atlantic Trident in the UK, conducted an Exercise in Ghedi, Italy and participated in the Dubai Air Show.

Away from flying operations, The Station hosted the latest UK/US Agile Combat Employment Working Group and 48FW conducted an Active Shooter Exercise in November. The Wing also successfully passed an Explosive Safety Inspection in December.

RAF Lakenheath continues to attract a plethora of visitors. During November and December, our visitors included the UK Minister for Defence Procurement, the US Deputy Secretary of Defence, the Czech Air Force and the United Services Organisation, the US leading charitable organisation in serving active-duty service members and military families who brought a group of celebrities, including Penn and Teller, to engage with, and perform for, 48FW personnel.

48FW supported over twenty-five events across Suffolk, Norfolk and Cambridgeshire over the Remembrance weekend. The Sqn Ldr had delivered a presentation on 48FW flying activities and his role as the RAF Commander to a community group in Holt, Norfolk early in November. The USVF hosted a Thanksgiving Service at Ely Cathedral on 22nd November and on 1st December 2023, 48FW hosted members of the local community at the Station for a Tree Lighting Ceremony and Yuletide Event.

48FW will be conducting night flying activities for two weeks starting 8th January 2024.

Finally, he informed the meeting that he would be leaving the RAF Commander job in the Spring to take up an appointment at RAF Marham. He will let us know the name of his replacement as soon as he has their details.

Cllr Lukaniuk thanked the Sqn Ldr for all his help. A few questions were asked by the public and Councillors, which the Sqn Ldr answered.

Cllr Wittam introduced PC Michael Harman, our Community Police Officer, to the meeting. PC Harman introduced himself and gave an overview of his role and how he can help the residents of Brandon. Cllr Wittam offered the opportunity to ask questions of PC Harman. A number of questions were asked by the public and Councillors to which PC Harman answered. PC Harman left business cards with his contact details.

Cllr Ridgwell queried if we were able to get any money regarding the bypass. Cllr Palmer responded to say there were no decisions as yet.

Cllr Lukaniuk commented that Cllr Ridgwell had made a good point. Cllr Lukaniuk further asked Cllr Palmer if he was able to let him know the names of the people he is working with on the bypass. Cllr Palmer did not wish to disclose this information to Cllr Lukaniuk and stated that when he has

any information the Council will be fully informed.

Cllr Ridgwell raised the subject of the government issuing money specifically for the repair of potholes. Cllr Lukaniuk commented that he would respond when he gives his report later in the meeting.

6 **URGENT BUSINESS** any items the Chairman considers a matter of urgent business. None.

7 TO RECEIVE WRITTEN REPORT from the Town Clerk.

Report was received. Cllr Lukaniuk enquired who the point of contact would be regarding the D-Day Event and asked for an invitation to the next Events Committee meeting.

8 PUBLIC FORUM monthly event limited to 3 minutes duration maximum per resident, this will include reports from County, District and Town Councillors also Community Group Representatives.

Cllr Lukaniuk confirmed that Suffolk County council have a massive budget deficit of several million pounds and in an attempt to balance their budget have transferred eighteen million pounds from reserves. Suffolk County Council are only able to increase their budget by five percent unless there is a referendum. Cllr Lukaniuk suggested that we need to prepare ourselves for further cuts. Cllr Lukaniuk further commented about the issue of potholes stating that he cannot personally repair potholes but he does follow up on the works and unless it is an emergency they can take twenty one days to be repaired.

Cllr Palmer asked if the Chairman could give the public an update on the Town Clerks position.

Cllr Wittam informed the meeting that the Town Clerk has now resigned his post.

Cllr Kostecki raised the issue of the old Collins Fish and Chip Shop and all the mess at the rear of the shop and that it could attract rats. Cllr Lukaniuk stated he had met with Environmental Health about the issues and he has asked them to progress the issue with the owner. Cllr Brocklehurst stated he had also contacted Environmental Health about this issue and asked that other people do the same. Cllr Lukaniuk suggested that they email Paul Speakman at West Suffolk District Council with their concerns.

A member of the public asked if the District Councillors could report back at the next meeting regarding West Suffolk Council offering the opportunity for the general public to comment on the up-and-coming council tax. The member of the public commented that it would be interesting to see how many people participated in the survey and what comments were taken into account when deciding the cost of the Council Tax. The member of the public was disappointed that it appeared that those people that did not have computers would not be able to take part and wondered if West Suffolk did this again could they make sure that everybody had the opportunity to be involved. A resident asked the Chairman what action had been taken to rebuild the confidence of the public, as a result of the 'Vote of No Confidence' at the last meeting. Cllr Wittam stated that he had been elected by the people of Brandon that he represents and there was very little else he could do. Cllr Wittam declined further discussion on this subject. Cllr Lukaniuk stated that he had every confidence in the Chair and Cllr Brocklehurst as the Vice Chair. Cllr Savage asked Cllr Wittam if he wouldn't reconsider his response to the public regarding the 'Vote of No Confidence. Cllr Wittam stated that he wasn't prepared to do that tonight.
